Re: Simply Essentials Poultry (P34668)

Dear Dr. Sprouls:

As you are probably aware, the Animal Welfare Institute (AWI) routinely requests and reviews humane handling records for all federal poultry and livestock plants. I am writing to express our concerns regarding the humane handling history of one particular plant in your district: Simply Essentials Poultry in Charles City, Iowa.

According to the records provided to AWI by the FSIS FOIA office, in 2017, your inspectors issued to Simply Essentials Poultry a total of 30 Noncompliance Records and Memorandums of Interview for practice not consistent with poultry "good commercial practices" (GCP). Most of these records describe humane handling problems related to transport and holding conditions.

To help put Simply Essential's bird handling record in perspective, I am attaching AWI's list of federal poultry plants with the most GCP records. You will see that Simply Essentials had the fourth highest number of records. However, while the list covers a three-year period (2015-2017), all of this plant's records were issued in just one year (2017), meaning that last year Simply Essentials Poultry received more GCP records than any other federal poultry plant in the country.

AWI has not yet reviewed GCP records for 2018, and it is possible that conditions at the plant have improved. We respectfully request that your office investigate the humane handling situation at the Simply Essentials Poultry plant, and if you deem it appropriate, send the District Veterinary Medical Specialist to conduct a review.
