In order to ensure that no administrative unit is overrepresented, not more than three members of the IACUC shall be from the same administrative unit. The facility must ensure that the IACUC does not contain more than three voting members from the same administrative unit.

(b) Each research facility shall establish and maintain programs of adequate veterinary care that include:(2) The use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries, and the availability of emergency, weekend, and holiday care

In a Principle Investigator laboratory, a clear plastic bag containing one brown tablet was observed. The label on the bag contained dosing information and date of prescription, but did not state the name of the medication, or the expiration date of the medication. A proper label including medication name and expiration date is essential in order to assure that animals are given the prescribed medications as directed and that the medications are not used beyond their expiration date as expired medications may be contaminated, may not work as expected, and could harm the animals. The facility must ensure that all medications maintained for and used on the animals are labeled appropriately.
